GL has invested in developing extraordinary youth leaders by challenging them to collaboratively confront complex global issues

Travel to Guatemala - 53 students completed 2495 hours of community service and local service learning. 3 school rooms were completed and 1600 trees were planted to minimize the effect of erosion. 564 hours were served at the Hospital Hermano Pedro. Every student received 35 hours of leadership training in country and 20 hours of one on one Spanish tutoring.

4b (Code:) (Expenses \$ 35,346 including grants of \$) (Revenue \$)
Travel to Ghana - 6 students traveled to Ghana for a maiden journey after scouting the project in 2014. Students built shelving and tables, donated books for a library, constructed a garden in an orphanage in Kumasi, and volunteered mentoring school children. Students completed 210 hours of community service in country.

4c (Code:) (Expenses \$ 62,285 including grants of \$) (Revenue \$)
Domestic Leadership Program - increased the membership base from 34 participants in 2014 to 76 participants in 2015. 59 participants were involved in the International Leadership Program, with 15 of those receiving financial aid. 17 participants were part of the Executive Board (no fee) and included past participants that returned to develop, implement, and celebrate service-learning projects and leadership training for current Leadership Program participants. Introduced Work & Earn financial aid program that combines fee waivers for low income students with access to mentorship through internship projects in Global Leaders office and throughout the local community. Over 3600 hours of community service-learning hours were completed with local non-profit and charitable organizations.
