



## Global Leaders Participant Agreement

I understand that the only unscheduled individual (non-group) time occurs within my home stay residence. I can allow room for surprise and adventure throughout the program and on the trip. ### **2.) Fees and Expenses**

#### **a. Participant Fees, Project Fund, and Price.**

The price of the trip/program includes the inclusions as advertised on the brochure for the trip/program for which I have signed up, specifically for 2017/2018: **\$3,000** plus airfare for families not requesting financial aid; and for families requesting financial aid, the program fee (based on sliding scale) that is agreed upon between parent/guardian and GL. This includes: host family and Spanish school; all meals, hotel accommodations, activities, park entrance fees and excursions, and transportation associated with excursions. I understand that round trip air fare to and from the U.S. to host country(ies) is additional. I agree to pay all fees associated with this trip and will sign separate documentation confirming my obligations to pay the participant fees.

In addition, I agree to raise funds for the GL Project Fund, or according to my financial aid agreement. I understand that fundraising can be an extremely positive and empowering experience for people of all ages and all backgrounds. I understand that the money raised for the Project Fund does not go towards my participant fees. The proceeds from the project fund are used for the projects we undertake locally and in Guatemala including school construction and reforestation. I agree to the fundraising goal for the Project Fund of \$700.

#### **b. Additional Fees associated with Trip.**

I understand that I am responsible for paying for additional snacks and refreshments beyond the three meals a day that GL will cover, **and also tips to host family, language school instructor and other staff of the host countries which totals \$120.** I will bring spending money and use it wisely. I understand that I will pay for any additional activities that I chose. I understand that I will be required to pay for any phone calls or incidental personal expenses that I incur at hotels, as well as for any damage I cause to hotel rooms, buses, or any other local property throughout the duration of my GL trip.

**c. Cancellation of GL Trip and Refunds.**

GL reserves the right to cancel my trip and refund my money in the event of currency fluctuations in my travel country(ies) of 10% or more, and GL may cancel a trip or program due to insufficient enrollment, unforeseen operational difficulties, lack of projected availability, global political instability or instability in the host country or any other reasons. If a trip is cancelled by GL, or myself, more than 90 days prior to travel date, a full refund **less cost of airfare** will be made within 25 days. If a trip is cancelled by GL, or myself, within 90 days prior to travel date, the following refund will be made within 25 days: **GL will refund the program fee less \$450 to cover program costs to date and less the cost of airfare.** This is GL's sole liability in the event that a trip is cancelled. Additionally, in the event that the trip is cancelled after airline reservations have been made, I will not receive refund on air tickets but will gain ownership of the air ticket purchased in my name for the GL trip I was to attend.

**3.) Travel**

I will not schedule anything during the three days prior and following the advertised trip dates in the event that travel dates are moved up or back. Fluctuations in air ticket prices and/or snow (school) days may change our departure and return from published dates.

**b. Inoculations, Securing of Passports, Travel Documents and Loss thereof.**

I understand that it is my responsibility to secure the necessary travel documents (passport) and/or visa in the case of some non-U.S. citizens. If I am not a U.S. citizen, I understand it is my sole responsibility to obtain, in advance, any visas and other documents which may be required to enter all the countries on my itinerary and to re-enter the United States. (Participants with passports from countries other than the U.S.A. must contact the local consular offices of the countries they will be visiting to obtain the necessary visas.) Such visas are not obtainable on the spot overseas. Further (whether a U.S. citizen or not), GL will be held harmless in the event I am unable to obtain the necessary documents for participation in the program. GL is not responsible for loss of passports, airline tickets (when not in the possession of a Group Leader), and other documents, or for loss of or damage to luggage or any other passenger belongings. GL is not responsible for locating lost property. In the case of a lost airline ticket, the participant is solely responsible for meeting the airline's requirements (both logistical and financial) for ticket replacement. I understand that I am responsible for making appointments and paying for any inoculations that I have chosen to get and any medicines that I have chosen to take prior to the trip and in preparation for the trip.

**d. Insurance/Trip Cancellation/Interruption Insurance.**

I understand that in the case that medical insurance is required, in most cases, my family's medical insurance policy is the primary insurance and GL's is the secondary insurance meaning that my insurance policy will be used first. GL carries General Liability and medical insurance to cover all activities within U.S.A. and internationally. GL also purchases supplemental travel emergency medical insurance (SRI) for participants and this insurance is also secondary to family's medical insurance policy. Supplementary insurance includes: medical benefit coverage with coinsurance (80%/20% to \$5,000, then 100% to plan maximum), emergency evacuation, return of mortal remains, Accidental Death and Dismemberment, Political Evacuation. I can request details on supplementary trip insurance for my records from GL. Trip Cancellation/Interruption Insurance is not provided by GL but is highly recommended. **4.) Personal Conduct**

**a. Conduct.**

I understand that for the health, safety and welfare of its staff and students, Global Leaders requires that the rules and regulations it establishes be observed. I understand that I am responsible for exercising caution and common sense at all times to avoid injuries. This includes programming and activities in my local community, and during the international trip. Where sidewalks are available, I will walk on them at all times. I will avoid dehydration and/or heat exhaustion by drinking recommended amounts of water, and take all needed precautions for myself to stay healthy. I will refrain from forming cliques, which undermine group cohesion. I will put the group's safety before my individual wants. I will always speak Spanish (or attempt to) when in company of Spanish speakers and when asked by GL Leaders. I understand that there are many limitations/differences as to what is considered acceptable behavior outside the USA.

**b. I understand and agree to certain non-Negotiable Rules (grounds for removal from program) which include but are not limited to the following:**

1. Use and/or the pursuit of use of alcohol, illegal drugs, prescription drugs for which I do not have a prescription or tobacco products.
2. Participation in exclusive relationships, sexual activity, or intimate involvement with other students is not allowed due to the emotional impact upon individuals and the group.
3. Unauthorized absence from the group or home stay or leaving the group alone at any point.
4. Disrespect, insubordination, or putting self or others or the Global Leaders reputation at risk or in jeopardy including any activities that threaten the physical or emotional safety of others including but not limited to harassment, theft, defiance of policies, whether intentional or due to ignorance.
5. Failure to abide by all host country and United States laws; I realize that laws differ between countries, and I agree to abide by the most restrictive of these laws at all times. I understand that should local authorities be involved, I will be subject to the laws of the country I am visiting.

**c. Misconduct and Expulsion.**



I agree that if I act in a manner in which, at GL's sole discretion, subjects any GL program, myself or other participant, leader or host to any risk of harm or disrespect, I may be immediately expelled from the program. If that occurs, I waive my right to a refund of any part of my program fees. I understand that GL will send me home at my own expense, (or in the case of misconduct prior to the trip, expel me from the GL program). If airline reservations have already been made at the point I am expelled from the program, I waive my right to any refund but will be given ownership of that air ticket. Additionally, I or my parents/guardians agree to pay for all costs associated with sending me home early including but not limited to collect phone calls, ground transportation, and additional labor by GL leaders. If I am sent home, I agree that I will pay retribution to GL by performing community service hours at its direction, writing letters of apologies to appropriate parties, and take such other appropriate steps to make amends as GL may request.

**6.) GL Liabilities and Waiver**

**a. Right to refuse Policy.**

I understand that GL reserves the right to refuse or cancel any registration/participant at its sole discretion. GL strives to build a positive group process; for that reason, GL reserves the right to refuse any participant prior to the trip and/or send a student home prematurely if the student causes discord in the group or with any program associated with GL. I understand that being selected to GL does not guarantee me a spot on a trip and that I must complete all the requirements asked of me in order to earn my spot on a trip.

My trip will include those things advertised on the current year GL brochure for said trip. No warranties, representations, terms or conditions apply to my trip unless expressly stated within current brochure. This includes, but is not limited to, any oral statements made by Group Leader(s), teachers, or anyone else otherwise affiliated with GL. Each trip begins with the takeoff from the GL departure gateway, under the presence of a Group Leader, and ends upon completion of the flight back to the GL gateway with a Group Leader. The official length of the trip does not include any stay ahead/stay behind options I have chosen. GL reserves the right to make changes in itinerary sequence, reversal of trip direction, airlines, hotels, field trips, activities, on certain dates, especially holidays, on which some activities may be closed. GL reserves the right to substitute activities. I understand that GL reserves the right to reassign participants a replacement teacher/Group Leader should the original teacher/Group Leader not participate in the program for any reason.

This agreement constitutes an agreement between GL and me with reference to the subject matter referred to herein, and I do not rely upon any promises, inducements, or agreements not stated herein, including but not limited to any oral statements made to me by any agents or employees of GL, or by my school or Group Leader, or any other person associated with GL. This agreement may be amended or modified only in writing.

This agreement shall be governed in all respects, and performance hereunder shall be judged, by the laws of the State of Colorado. Any claim or controversy arising hereunder or relating hereto shall be settled by arbitration before a single arbitrator in Colorado in accordance with the Commercial Arbitration Rules of the American Arbitration Association then in effect. The award rendered by the Arbitrator shall be final, and judgment may be entered upon it in accordance with applicable law in any court having jurisdiction thereof in the State of Colorado. Notice of the demand for arbitration shall be filed in writing with the other party to the agreement and with the American Arbitration Association in accordance with the Commercial Arbitration Rules of the American Arbitration Association then in effect. The demand shall be made within six months after the claim, dispute or other matter in question has arisen, or shall be forever barred.
